### **Executive summary**

On 11<sup>th</sup> September 2021, Campaign Against Child Labour(CACL) Bihar, in collaboration with National Advocacy Unit (NAU), organized State Level Consultation on 'Issues, challenges and Possible ways for the Child Labour Eradication in the state'.

In the consultation 52 participants (Annexure I) including professor from universities, institutions and member organizations of CACL, and CCHT (Collective Coalition Against Human Trafficking) participated. All participants shared their rich experiences and give recommendations to eradicate bonded & child labour from the state of Bihar. Due to well thoughtful schedule (Annexure II) workshop took a wonderful action-oriented shape in the presence of very vibrant participants as well as the knowledgeable speakers, academicians and motivating guests. The workshop began with the welcome of all participants and sharing of objectives and agenda of the state level consultation. Following this Mr. Nawlesh Kumar Singh, State Convener, CACL Bihar introduced the consultation and requested Mr. Pramod Kumar Sharma to Chair the consultation and to share his views on the objectives of the consultation with participants. Mr. Nawlesh Kumar Singh also requested Mr. Suresh Kumar, child Right Activist to facilitate the sessions in the absence of Dr. Anil Kumar Roy, State Convener, RTE Forum Bihar Chapter. Subsequently, during the Context Setting session Mr Ashok Kumar, Convener, National Advocacy unit, CACL discussed about the strengthening the campaign in the state towards total complete eradication of child labour.

Following this, the Panel discussion was began where distinguished speakers like Mrs Gargi Saha, Child protection officer, Unicef, Mr. Sachin Kumar, Programme Advisor, Freedom Fund, Mr. Suresh Kumar, Child Rights Expert and Piyush Kumar, Save the Children shared their rich experiences and considerate views on 'Issues, challenges and Possible ways for the Child Labor Eradication in the State and discussed about the strategies to ensure the basic rights of children in the context of COVID 19 Pandemic.

The Open house discussion was moderated by Mr. Suresh Kumar, Advocate, Child Right Expert. The key discussion points were; role of academicians to give evidences to policy makers for making changes in existing government policies, use of technology to spread information about child Labour issue as well laws like CLPRAA,2016 as government schemes to combat it at mass level, civil society can play significant role like CACL is playing in their projects. It was shared that engagement of youth, need of more field researches and study on Child Labour issues are necessary for the better implementation of government schemes, push and pull factors of laws related to child Labour, difference between child labour and working child, rehabilitation of rescues victims, engagement of community and local leaders and capacity building of stakeholders in order to achieve total eradication of child labour in the state.

After the open house discussion, there was follow-up discussion on the action points decided in the last meeting held on 19<sup>th</sup> March 2021 which was facilitated by Mr. Pramod Kumar Sharma, Member Core Group, CACL Bihar and State Convener HLN. Subsequently, Ms. Suman Singh, Member, core Group discussed about her views and grass root experiences on strengthening/Energising state chapter of CACL.

After this session Mr. Nawlesh Kumar Singh, State Convener, CACL Bihar and Mr. Akshay Kumar, State Convener, Lokshala Abhiyan shared their ideas and suggestions on developing Action plan/ Road map and possible areas of collaboration for child labour free Bihar.

### **Highlights of the Consultation**

### **Inaugural Session**

The State Level consultation on 'Issues, challenges and Possible ways for the Child Labour Eradication in the state began under the chairmanship of Mr. Pramod Kumar Sharma, Member CACL, Centre DIRECT. Mr. Nawlesh Kumar, State Convener CACL requested to all participants to share their name & organization. After introduction of participants, he welcomed all the guests. Following the introduction session of CACL he shared agenda in brief and said "according to census 2011 around 14.4 million children, or 37 percent of India's population, are below the age group of 18 years. He further said that 99 million children in total have drop out of school and census 2011 indicates that there are over 8.2

million child labours in the country. He also shared that poverty, unemployment/ underemployment, caste and gender discrimination, low level of education, inaccessibility to social security measures are the main causes of child labour as the increasing gap between the rich and the poor, privatization and economic reforms

has adversely impacted the children. He also put emphasis on human trafficking, bonded labour and child labour are very sensitive issues and we all are here to discuss on these issues.

# Session 1- Context setting-strengthening the campaign in the state towards total eradication of child labour

Following the very motivating and promising inaugural session facilitator invited Mr. Ashok Kumar, Convener, National Advocacy Unit -CACL to set the context of the consultation. During this speech Mr. Ashok Kumar, addressed participants and congratulated the organizers for organising such a useful consultation and promised for full support from Networks like CACL, HLN, CSOs and institutions like CNLU Patna on this issue . While

discussing about the objective of the consultation, he said that, there is a lot of amendments related to child labour laws in last five years. He said that, we need to deeply co-relate the child labour issues with the COVID 19 pandemic. CACL Bihar team already discussed about various issues in

the previous meeting and said that CACL need to have change in the context of child labour issues and there is a need to observe SWOT analysis in terms of vision and mission of the CACL. He further said that, there is a need for continuous dialogue with govt stakeholders, Partners, Networks, CSOs and NGOs who have been working on the issues of child labour. There is a need to ensure proper implementation of integrated child Protection Scheme in order to work with WLCPC (Ward Level Child Protection Committee) and SCPC (State Child Protection Committee).

Resource mapping and Data always play an important role for studies, researched and making policies and due to lack of exact data we always struggle with good policies that can address social issues like human trafficking, child labour and bonded labour, said by speaker. The speaker suggested that, there should be vulnerability mapping of aspirational district. the phenomenon of exploitation of vulnerable people began to be recognizing as an evil and unacceptable practice by government and came up CLPRA. The purpose of the Act was to prevents the cases **of child labour** which is have not decreased. **In** fact, has been growing day by day due to unpresented COVID 19. We need to work with media because media can play vital role in Awareness of community towards the issues of child labour and bounded labour.

#### Session 2: Panel Discussion:

# Theme: Child Labour scenario in Bihar and strategy to ensure the basic rights of children for making the state child labour free.

After a short tea break at 11: 20 am, the moderator of the session invited Ms. Gargi Saha, Child Protection Officer, Unicef for sharing her views and suggestions to make the state

child labour free. Ms. Gargi Saha, congratulated the CACL team for its constant efforts to ensure the basic rights of children for making the state child labour free. She informed that around 30 lakhs people's reverse migration took place in Bihar therefore we need to make proper action plan and ensure its implementation with the support from grass root organization working in the field to address child labour

issues appropriately. Ms. Gargi Saha said that, this is a ground reality that there many more people who are forced to live life like bonded labour. Social and behavioural change is very difficult so child friendly police station should be formed in every district and CSOs and other stakeholders should be involved in running those child friendly police stations.

Every year numbers of bonded labours are increasing by 25% (including men, women and children) and this situation became worst after the COVID 19 pandemic. Many of them are in the condition that they are working from their 3rd generation and their children are also involved in these works. Their children are also living a bonded life like them, and to end this kind of situation our organization UNICEF is working with the government through our

partners. She also urged the participants that we should work together to address these sensitive issues.

After this sharing session, facilitator invited Mrs Ritu Mishra, Programme Coordinator, North Region, Terre des hommes, Germany – India Programme to share her views. She said that we have enough data and evidences related to the incidences labour of child

available to us but it should be properly collected and reviewed. Ms. Ritu said that education plays significant role in fighting against child labour. Whenever we talk about human trafficking, child labour and bonded labour then district administration starts running away from its responsibilities. She stated that the policy should change as per the need of time and government should improve our old policies. Academicians, NGOs and CBOs may play a significant role in developing strategies to ensure basic here to give evidence to government for making changes in present policies through their studies.

Moving forward with the panel discussion Mr. Suresh Kumar, Advocate, Child Rights Expert,



expressed his views on the enriching panel discussion and said that state action plan should be strengthen and should be properly reviewed so that we can get to know about where we have reached or what we the have achieved in previous year. He said that we need to send written letter to all the concerned government departments so that issues related to child

labour and re- trafficking could be addressed. The biggest help can be done by our bureaucrats because they understand all the aspects of field better than anyone else and these kinds of workshops should be done with the people of the same area so that they can help to improve the policies, added by him. He sum-up his views and said that should

undertake traditional research work focusing on the human trafficking, sex trade and poverty, strategy for elimination bonded / forced labour & child labour, effective practices for take-off rehabilitation.

Following this very informative speech, moderator requested to Mr. Sachin Kumar, Programme Advisor, Freedom Fund. Mr Sachin thanked to all the academicians came in the consultation and

shared the experience. He said that for the last many years, he has been working on the bonded labour and human trafficking issues. As per my experience, coordination and collaboration between government non-government organization is very important. Looking at the data of in previous session, he said that the data of the child labour is actually the data of the children who are involved in labour activities but in reality, it is too high and has been substantially increased in the COVID 19 pandemic as we can see children in our daily life working at tea or food stalls. We have to work to fill these types of gaps, because the data we see in the paper and in reality, are different. We need to link education and which is the major component to fight against child labour and this issue should be raised at national level. Mr. Sachin, further discussed about the allocation of budget on child protection which is considerably low and NGOs need to be updated for the effective working against child labour and bounded labour as sometimes the government does not want to see the data that comes from NGOs. In today's society people still think that the bonded labourer will be a hostage or they will not have the freedom to visit but now days there are many people who are being controlled by money lenders and kiln owners and forced them to live with them for 20 years. He drawn attention of all academicians and said that it is a right time to work in collaboration and as an academician we have to come forward to eliminate bonded also try to work for wellbeing of child labour and bonded labour. He labour issue and winded-up his words with the promise that he will continue his work in wellbeing of child labour and bonded labour with is dedicated team of CACL.

Subsequently, moderator requested to second Mr. Piyush Kumar, Programme Coordinator,

Save the children, to share his views in the panel discussion. He said that It is very appropriate that this consultation is being held. Concerning with the increasing magnitude of problem of child the labourers in the in Bihar and increasingly younger age of victims of child labour, the Department of Labour Resources, Government of Bihar had set a Child Labour Tracking

System (CLTS) and made laws like CLPRAA, 2016. One of the objectives of the state level consultation is not only to critically analyse the laws and policies but the government squarely fails to overcome the problem as they talk about only child. If children are seen in isolation of their families, the problem goes unabated. I am very happy that all of you from CACL, member of network organization, academicians' other participants of the house who are concerned with making our systems function are here to see how we can make our systems more responsive and effective by strengthening the implementation of ASTITVA guidelines, RTE and school enrolment. As far as the needs of the rescued child labour are concerned, we need to give more importance to education not on life skills.

He further explained about his experiences where he learned that implementation of laws, action plans and policies relating to child labour with special emphasis on effective rescue and post-rescue rehabilitation strategies, which should be adopted in the case of Child Labour. He said that "I want to make sure that every youth and adolescent should be united to make this day remarkable to fight against this social evil and strengthen community with child protection laws as it is important for overall development of women, child and youth. They play most important role in society". He further concludes his speech and said that kinds of welfare schemes do not reach to actual beneficiary. People of especially the youths our country need to be aware the pros and cons of child labour and develop common strategies to for fight against this crime then only we can make our dream (child labour free country) true.

Session ended with felicitation of speakers and moderators and facilitator invited everyone for lunch.

### Session 3: Open House Discussion

Then moderator extended thanks to all the panelists and said that "all of you opened the whole box of knowledge through facts and data. Subsequently he invited participants for open house discussion.

Mr. Ashok Kumar, National Convener, National Advocacy Unit-CACL, said that CACL has developed its website and it will also develop online resource centre, and for this he thanked Mrs. Ritu Mishra for providing the technical support. He urged all the participants to provide their regular support in organizing such a fruitful dialogue , discussion & consultation on regular intervals in Bihar . Mr. Pramod Kumar Sharma, Member core Group, CACL

Bihar and State Convenor, HLN agreed and said that we will come together every month to discuss the issues and challenges of child Labour eradication and also said that we can seek support from academic institutions like Chanakya National Law University (CLNU) for their support in evidence-based research work and studies on Child Rights and child protection issues .

Then Mr.Ritu Raj, Secretary, Narayani Sewa Sansthan, Hazipur, said that, the data collection is a very big challenge in research work. If we go to collect the data anywhere then we cannot find the exact data. In order to collect accurate data, we have to understand the circumstances and get information from different sources and write it accordingly. He said that children rescued from bounded labour are not getting compensation. Ms. Suman Singh, Member, Core Group, CACL, Bihar and State Convener,CBATN highlighted biggest challenge to , child and bonded labour system is the lack of accurate data. As a field worker we always face trouble for accurate data because when even anyone want to do research, they don't get exact data and when any grass root worker wants to make strategy to address issue, they also face same. Another challenge she shared was lack of rehabilitation plans with agencies. She stated her experience as CWC member, that there are many children to whom we have restored in their families after their counselling and medical but after some time the same children came again before us. She advised to do to involve CWC process and take initiative to help the children and to stop bonded labour.

# Session 4: Follow-up-Discussion on the action points decided in the last meeting held on 19<sup>th</sup> March 2021. Strengthening energising state chapter of CACL

This session was facilitated by Mr. Pramod Kumar Sharma, Member Core Group, CACL Bihar and State Convenor, HLN. He briefly discussed on the action points decided in the last meeting held in the month of March 2021. He said that due to unprecedented COVID 19 lockdowns, the social sector faced lots of challenges in implementing regular activities but how ever we have been giving constant support in strengthening networks like CACL and HLN so that child labour problems could be addressed at grassroot and as well as State level. He further said that we have identified Gaya district which is hot spot of child labour in the state. During COVID -19 lockdown we have done 2 DCPC meeting and tried to develop regular communication with the concerned departments and we have tried to gather data from the government departments. He suggested all the participants and said that "If we want to work towards system strengthening, we need to agree on Non-financial MOU and if we will do financial MOU then I think as a network we will not be able to work with the government." He added that, we need to work on certain mandate of State Action Plan to eliminate child labour and we can do advocacy at all levels. We need to take oath from all the elected representative at ward and panchayat level on the issues of child labour and for this we can take support from the networks and partner. We need to develop strategies and raise demand to strengthen gram and ward Sabha if we want to implement sate Action Plan at grassroot level.

Subsequently, during this Session Ms. Ritu Mishra and Mrs Suman suggested that during Aam Sabha and Gram Sabha election process, there is a need to empower communities, especially children, youths and women so that they can have better understanding over child protection issues and right based approach so that they can raise their demand in front of elected representatives.

# Session 5: Developing Action Plan/Road Map for child labour free Bihar. Possible areas (Sector and geography wise) for collaboration- possible partners for collaboration.

The moderator extended thanks to the speakers and invited Mr. Nawlesh Kumar Singh, State Convener, CACL Bihar to suggest his views on developing action plan /road map for Child labour. He said that, at panchayat/block level need to strengthen 3 legal committees that is CPC, VHSNC (Village Health, Sanitation and Nutrition Committee) SMC (School Management Committee) so that we can work efficiently in order to identify the gaps and challenges related to child labour and protection issues. We need to strengthen vigilance mechanism at community level. We will formulate state, division and local level action group at district level and we will discuss and prepare questionnaire on this basis and prepare/collect case study that in which areas/ districts cases of child labour have increased. He added that, there will be 15-members of State Level Action Group consisting of members of networks, civil society organization, team of social activists and also a member of Department of Labour Resources. Poverty, lack of education & community awareness is emerging the main causes of bonded labour and human trafficking in the state . He also added that due to lack of implementation of State Action Plan of Bihar government, and lack of knowledge about social security schemes, situation is getting worst day by day. Hence we recommend that we should do regular community meetings to make them aware about government schemes and facilities. We will establish online resource centre with the support of networks and partners for the purpose of sharing reports, research paper and studies based on the child labour issues.

In the light of child labour eradication Mr. Akshay Kumar, State Convener, Lokshala Abhiyan said that till date we have been looking at the issues of child labour in part/portion. When we look at the problems in part, it is natural that the nature of its solution will also be the same. But today the situation has changed. Today problems have to be solved in totality.

Mr. Chandra Bhushan, Member, Core group, CACL given vote of thanks and Session ended with felicitation of speakers and moderators and facilitator invited everyone for lunch.
